Emerging Technology in Local Government

How can local governments better harness the power of new technologies? This panel will discuss machine learning and artificial intelligence as training tools and introduce innovative software solutions to increase county efficiency.

Morgan Gray, Esq., is currently pursuing his Ph.D. in Intelligent Systems at the University of Pittsburgh and is an adjunct professor at the Thomas R. Kline School of Law of Duquesne University.

Kevin Ashley, Ph.D., is a Professor of Law and Intelligent Systems at the University of Pittsburgh, a Senior Scientist at the Learning Research and Development Center, and a faculty member of the Graduate Program in Intelligent Systems.

Cory Fregm, CEO of Teleosoft Inc., has a diverse background in technical sales, strategic account management, and business operations, and has focused on helping county governments since 2014.

Jason Henry-Ruhl is the Senior Product Manager for Teleosoft's CountySuite Courts team, demonstrating a unique ability to create positive outcomes for county government stakeholders.

Merger of Wheatland Borough and City of Hermitage

Municipal merger and consolidation is a complex process. The recent merger of Wheatland Brough, a small, initially financially distressed borough, with the City of Hermitage, a fiscally health city, was no exception. Lynne Shedlock and Terri Cunkle discuss their experience helping to guide these municipalities, through Pennsylvania's Strategic Management Planning Program, through the merger process, focusing on both short- and long-term goals and impacts, ultimately resulting in an approval vote in both communities.

Lynne Shedlock is the current acting executive director of the Pennsylvania Economy League. She is responsible for PEL reports completed under the state's Strategic Management Planning (STMP) program for local governments and for similar technical assistance projects.

Terri Cunkle, who has over 15 years' experience in local government, serves as the Northwest Local Government Policy Specialist with the Pennsylvania Department of Community and Economic Development, Governor's Center for Local Government Services. Terri formerly served as administrator for a second-class township and as a DCED peer-to-peer.

Municipal Legal Update

The legal environment is constantly changing, and the field of municipal law is certainly not immune to such changes. Municipal solicitors and officials alike need to stay current on legal trends, new legislation, and court cases impacting municipal practice. Sam Wiser discusses recent legal updates that impact municipalities and "hot topic" areas for local government officials and solicitors to keep an eye on.

Samuel Wiser, Esq., has provided comprehensive legal services in the areas of municipal law, zoning and land use, environmental law, and general litigation for 17 years, and serves as the chair of Salzmann Hughes, P.C.'s municipal practice group, which represents over 100 municipalities throughout the Commonwealth. In addition to serving as solicitor and special counsel to many municipalities and authorities, Sam also frequently serves as a guest speaker and presents for various municipal associations.

Sam earned his undergraduate degree from Shippensburg University of Pennsylvania in 2003 and his J.D. from Widener University of Commonwealth in 2006.

Land Use Best Practices

Growth and development are paramount to the health of a municipality. However, managing community development requires a delicate balance by the municipality. This panel will discuss current trends in land use, including logistics and warehouse zoning as presented in PennFuture's report and accompanying model logistics use zoning ordinance.

Brigitte Meyer, Esq., the lead author of PennFuture's *Living with Logistics* report, is a Staff Attorney in PennFuture's Pocono Office, where her work focuses on land use, water quality and watershed protection, special protection waters, and stormwater management.

Eric Brown, Esq., is a Partner in the law firm of Siana Law, where he serves in the Firm's Solicitor, Employment & Labor Law, and Litigation Practice Groups. As part of his work, he counsels municipalities and municipal officials on a broad range of legal issues confronting the daily management of local governments.
