 to Second Class A Counties**

Note: Provisions of the Second Class County Code are repealed insofar as the effect upon counties of the second class A. Sections of the Second Class County Code which are marked omitted from integration into the County Code have the effect of repeal as to second class A counties. Sections of the Second Class County code which are marked “n/a” were interpreted to apply to second class counties only; such sections are not integrated, and do not impact counties of the second class a. The Second Class County Code provisions cited below are cited as to the integration into the proposed County Code Revision. Provisions marked (^) refer to the imposition of hotel room rental taxes; these provisions are not amended and County Code has previously been amended to contain the relevant provisions related to counties of the second class A.
